Subject: Intimation regarding reduction in Issue size of Convertible Warrants on Preferential Basis from 37,50,000 to 18,84,000 Convertible Warrants

With reference to the Board Meeting held on 27th September, 2025 we hereby inform you that the issue size of Convertible Warrants on preferential basis has been reduced from 37,50,000 to 18,84,000 at the issue price of Rs. 264.75/- (Face Value: Rs. 10.00/- each and Premium: Rs. 254.75/- each). Consequently, the total issue amount stands revised from Rs. 99,28,12,500/- to Rs. 49,87,89,000/-.

The said issue was originally approved by the Board of Directors at its meeting held on 30th November, 2024 and subsequently by the shareholders at the Extra-Ordinary General Meeting held on 27th December, 2024, for the issuance of 37,50,000 Convertible Warrants on a preferential basis at a price of Rs. 264.75/- (Face Value: Rs. 10.00/- each and Premium: Rs. 254.75/- each) to person(s) and/or entity(ies) belonging to the Non-Promoter Category, aggregating to Rs. 99,28,12,500/-.

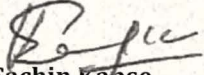
